## Recovery and Resilience Facility – EUR 723.82 billion \*

The Facility entered into force on 19 February 2021. It finances reforms and investments in EU Member States made from the start of the pandemic in February 2020 until 31 December 2026. Countries can receive financing up to a previously agreed maximum amount. The facility is structured around six pillars, one of which is titled 'health, economic, social and institutional resilience', with the aim of, inter alia, increasing crisis preparedness and crisis response capacity.

To benefit from support under the Facility, EU governments have submitted national recovery and resilience plans, outlining the reforms and investments they will implement by end-2026, with clear milestones and targets.

The Slovenian National Recovery and Resilience Plan gives an example of the Health Pillar:

'The Slovenian plan contains large investments in hospital infrastructure to improve the effective treatment of communicable diseases in Slovenia. The plan includes two hospital infrastructure projects aimed at increasing and upgrading the capacities to treat communicable diseases in Slovenia: (a) the upgrading of the infectious clinic in Ljubljana and (b) the construction of a new infectious clinic in Maribor. Both facilities are expected to enter into use by mid-2026 and are expected to provide more than 200 additional beds for the treatment of communicable diseases'

EU Cohesion Policy contributes to strengthening economic, social and territorial cohesion in the European Union. It aims to correct imbalances between countries and regions. EU Cohesion Policy invests in health, a key asset for regional development and competitiveness, to reduce economic and social disparities. Investment may address several different areas such as Europe's ageing population, healthcare infrastructure and sustainable systems, e-health, affordable access to quality health services, health promotion programmes and cross-border cooperation.

The first pillar of Horizon Europe - Excellent Science - supports frontier research and breakthrough scientific ideas, teams up the best researchers from Europe and beyond and equips them with skills and world-class research infrastructures.

Applications can be made in any field of research. The ERC's grants operate on a 'bottom-up' basis without predetermined priorities.

### Horizon Europe Pillar II

#### Global Challenges and European Competitiveness - EUR 53 billion

##### Cluster 1 – Health – EUR 8.25 billion

The pillar is established through clusters of research and innovation activities, in order to maximise integration and synergies across the respective thematic areas while securing high and sustainable levels of impact for the Union in relation to the resources that are expended.

Selected areas of intervention:

- Infectious diseases including poverty-related and neglected diseases.
- Healthcare systems.

Expected impact linked to the areas of intervention:

- Tackling diseases and reducing disease burden

- Pandemic preparedness.

Main areas for international cooperation and activities to be aligned with Research and Innovation of third countries/regions at major scale or to be carried out in cooperation with organisations in third countries:

- Infectious diseases, antimicrobial resistances and public health emergencies through dedicated actions and multilateral initiatives, including One Health approaches, such as the European and Developing Countries Clinical Trial Partnership (EDCTP), the Coalition of Epidemic Preparedness Innovation (CEPI), the Global Research Collaboration for Infectious Disease Preparedness (GloPID-R) to prepare and respond quickly to public health emergencies in Europe and worldwide, and the Access to COVID-19 Tools (ACT) Accelerator to accelerate the development, production and equitable access to new COVID-19 diagnostics, therapeutics and vaccines.

## Asylum, Migration and Integration Fund – EUR 9.88 billion

The Asylum, Migration and Integration Fund aims to further boost national capacities and improve procedures for migration management, as well as to enhance solidarity and responsibility sharing between Member States, in particular, through emergency assistance and the relocation mechanism.

Example action:

- supporting infrastructures for the reception of third country nationals, including the possible joint use of such facilities by more than one Member State.

## EU4Health – total EUR 5.75 billion

The EU4Health programme was adopted as a response to the COVID-19 pandemic and to reinforce crisis preparedness in the EU. The pandemic highlighted the fragility of national health systems. The EU4Health programme will bring a contribution to the long-term health challenges by building stronger, more resilient and more accessible health systems.

The EU4Health Programme has four general objectives representing the ambitions of the programme and ten specific objectives representing the areas of intervention:

- **Improve and foster health**
  - Health promotion and disease prevention, in particular cancer
  - International health initiatives and cooperation.
- **Protect people**
  - Prevention, preparedness and response to cross-border health threats
  - Complementing national stockpiling of essential crisis-relevant products
  - Establishing a reserve of medical, healthcare and support staff.
- **Access to medicinal products, medical devices and crisis-relevant products**
  - Ensuring that these products are accessible, available and affordable.
- **Strengthen health systems**
  - Reinforcing health data, digital tools and services, digital transformation of healthcare
  - Enhancing access to healthcare
  - Developing and implementing EU health legislation and evidence-based decision making
  - Integrated work among national health systems.

## Technical Support Instrument – EUR 0.86 billion

The Technical Support Instrument is the EU programme that provides tailor-made technical expertise to EU Member States to design and implement reforms. The support is demand driven and does not require co-financing from Member States. It is an important pillar of the EU's initiative to help Member States mitigate the economic and social consequences of the outbreak of the COVID-19 crisis.

The European Commission, via the Technical Support Instrument, has been helping Member States with the preparation and implementation of their national Recovery and Resilience Plans.

An EU Member State wishing to receive technical support submits a request to the Commission, via a national Coordinating Authority. A request must be submitted by 31 October of each year.

One of the areas supported is:

- Health and long-term care
